Draft Artist Statement:

The history of art is filled with examples of how artists have responded to the times they lived in. It is indisputable that the COVID 19 pandemic has had a profound impact on individuals, communities, and nations the world over. To accompany the artworks, this exhibit with feature artist statements that address themes relating to how the COVID 19 pandemic has affected you, your art, and your art practice. Please consider these or similar concepts as you draft your statement.

- ~ There have been seismic shifts in the work and social lives of everyone living through this period. In what ways have these changes realigned your art (subject matter, scale, style, materials, volume, etc.) or art practice (workspace, opportunity, motivation, etc.)?
- ~ What has characterized the nature of the art you created during this period?
- ~ Does the work you submit in some way express themes so many people have been encountering during this past year (fear, disruption, isolation, etc.)?
- ~ Loss has been a profound component of the pandemic in both the physical (death, separation) and metaphoric sense (lost opportunities). Does your work memorialize loss in some way?
- ~ With vaccines and other positive news on the horizon, does your entry in some way reflect the hope of a world reopening?

In addition to addressing themes relating specifically to this exhibit, the artist statements will be posted alongside the work in the gallery.

Please submit your statement, as a word document; size 12 arial font, double spaced, limit of 20 lines to lemontcenterarts@gmail.com by May 1, 2021 with the words Locking Down/Opening Up in the subject line. Don't forget to include your name on the statement
